#### INSTRUMENTAL MUSIC PROGRAM

Padua College provides students with the opportunity to engage in a dynamic Instrumental Music Program, thoughtfully designed to offer a diverse range of options and musical pathways. Our aim is to support students in their musical pursuits, regardless of the style they wish to explore.

The Instrumental Music Program at Padua College accommodates a wide range of musical interests, including classical, jazz, pop, rock, and ensemble performances. We are confident that participating in music will be a fulfilling and enriching experience for our students, contributing significantly to their overall education at Padua.

#### PROGRAM STRUCTURE

There are three main streams in which students may participate:

- 1. Instrumental Music Lessons
- 2. Ensemble Program Concert Bands, String Ensembles, Vocal Groups
- 3. Contemporary Bands Program Year Level Rock Bands, Stage Band, Groove Orchestra

#### 1. INSTRUMENTAL MUSIC LESSONS

#### LESSONS ARE AVAILABLE ON THE FOLLOWING INSTRUMENTS

Percussion:	Drum Kit / Percussion
Voice:	Contemporary / Classical
Piano/Keyboard:	Contemporary / Classical (individual lesson only)
Piano/Voice:	Combined lesson (individual lesson only)
Guitar/Voice:	Combined lesson (individual lesson only)
Speech & Drama	Individual (& small group lessons for Year 7 only).

#### SPEECH & DRAMA LESSONS

Our new Speech & Drama program offers students from Years 7 to 12 the opportunity to develop their acting, public speaking, and presentation skills. Lessons are available both individually and in small groups for Year 7 students only, tailored to meet the needs of each student. Participants will engage in a variety of activities designed to enhance their verbal fluency, self-confidence, and creative expression. The program also prepares students for external examinations (Trinity/AMEB) and provides support for those interested in VCE Theatre Studies, Drama, or auditioning for theatre roles.

#### LESSON COUNT AND MUSIC TUITION FEES

An annual quota of 30 lessons is provided in three blocks of 10 lessons each. Music Tuition Fees will be charged on **27 February 2025, 01 May 2025 and 31 July 2025** (independent of School Fees).

Students enrolling late may be billed at a pro-rata basis. Confirmation of enrolment is subject to availability and payment of the appropriate Tuition Fees.

Students may be offered additional lessons in Term 4 (at a per lesson cost) if their annual quota has been completed and sufficient time is available.

Sessions conducted for VCE/VET Music students as part of exam preparation or for assessing and providing performance feedback will be counted towards the annual quota.

\*Shared lessons are only suitable for Year 7-9 students. If a student cannot be matched with someone of similar experience and ability for a shared lesson, they will be offered an Individual 30-minute lesson at the applicable rate.

#### ENROLMENT PROCEDURES

Please complete the attached enrolment form and return to Campus Reception or Mornington's Performing Arts Office.

#### LESSON TIMES

Students are expected to arrive punctually and be adequately prepared for their lessons. Lessons are scheduled during school hours on a rotating basis to ensure that students do not consistently miss the same class. Fixed lesson times can be arranged through negotiation with the designated Instrumental Music Teacher, with priority given to Senior School students. In the event of an unavoidable excursion or test, students must provide a minimum of one week's notice.

#### STUDENT ABSENCES

**PLANNED** absences, either of a personal nature (appointment, holiday etc.) or for a school activity (excursion, camp, test etc.) require **one week's notice** for a make-up lesson to be provided. Please email the Music Office (<u>music@padua.vic.edu.au</u>) and your child's Instrument Music Teacher with details of the absence.

UNPLANNED – in the case of illness etc, please email the Music Office (<u>music@padua.vic.edu.au</u>) and your child's Instrumental Music Teacher by 8.00am on the day of the scheduled Music lesson.

Lessons missed by students without adequate notice will forfeit the cost of the missed lesson and a make-up lesson will not be provided.

#### TERMINATION OF LESSONS

To terminate Instrumental Music Lessons, a minimum of **five (5) weeks' notice** is to be provided **prior to the next billing period**. If less than five (5) weeks' notice is provided, a pro-rata fee will be charged in the next billing period. Written notice of termination should be emailed to the Director of Performing Arts (<u>music@padua.vic.edu.au</u>). Instrumental Music Fees are not refundable except at the discretion of the Director of Performing Arts.

#### CHANGE OF INSTRUMENT OR TEACHER

Changes to instrument or instrumental music teachers will only be considered at the beginning of a new semester. Please submit your request in writing, addressed to the Director of Performing Arts for review. We kindly request a notice period of three weeks.

#### INSTRUMENTAL STORAGE AND INSURANCE

All instrument cases MUST be labelled with the student's name and telephone number. The College cannot take any responsibility for instruments owned by students if lost, stolen or damaged. We strongly recommend that instruments are covered by a suitable insurance policy.

The Mornington Performing Arts Centre provides instrument lockers for Music students. Students can visit the Music Office in the Performing Arts Centre to have a locker allocated. Safe storage spaces are available at the Rosebud and Tyabb Campuses.

#### PADUA PERFORMANCE PROGRAM & CULTURE

Throughout the school year there are a variety of performance opportunities for these performers including Rock Concerts, Band Festivals, Gala Concerts, Soirees, Assemblies, Festivals, lunchtime concerts, College Productions, talent quests and liturgical events. Participation in events such as these provides students with the opportunity to build self-esteem in a performance environment. These performances often become a highlight of their College life.

All students enrolled in Instrumental Music Lessons or Voice Tuition at the College are required to participate in the College Ensemble and Bands Program. This entails availability for membership in the suitable Ensemble, Band, Rock Band, or Vocal Group. Rehearsal schedules for these ensembles will be established at the beginning of the school year, following the finalisation of staffing. Please note that some ensembles may require an audition for participation.

#### 2. ENSEMBLE PROGRAM

#### YEAR 7 & 8 - TRAINING BAND AND JUNIOR STRING ENSEMBLE

Padua College offers Year 7 & 8 students the opportunity to participate in the Training Band or String Ensemble Program. Students who wish to learn one of the instruments listed below are offered a <u>50%</u> <u>discount</u> on instrumental lessons in Years 7 & 8. Instruments included:

Woodwind (Flute, Clarinet, Saxophone, Oboe, Bassoon)
Brass (Trumpet, Trombone, French Horn, Euphonium, Tuba),
Strings (Violin, Viola, Cello, Double Bass)
Percussion (Timpani, Glockenspiel, Xylophone)

Bass Guitar \*limited positions available

Piano, Voice and Guitar lessons are not included in this program.

All students receiving discounted lessons **are required to actively participate** in either a Concert Band or String Ensemble. Regular attendance at ensemble rehearsals is essential; failure to attend without a valid reason may jeopardise a student's position in the program. Additionally, students enrolled in the Year 7 & 8 discounted program are expected to commit to the program for the entire school year.

Students will need to provide their own instrument, although some College instruments are available for a modest rental. Students who come into Year 7 with prior musical experience will be placed in a band or ensemble appropriate to their skill and experience.

#### YEARS 9-12

Students in Years 9-12 who learn a Concert Band or String instrument are encouraged to play in a College band appropriate to their skill level and experience. After graduating from the Training Band Program students can join a campus-based Concert Band, Strings Ensemble and/or Percussion Ensemble. Students may also be invited to play in the College Stage Band or Groove Orchestra. While the ensembles offered may vary from campus to campus, there are relevant ensembles on at all campuses.

#### VOCAL GROUPS

Each campus aims to create opportunities for students to join a Vocal Group. Vocal Groups are open to anyone who is interested in joining. Students who are studying an instrument or undertaking curricular Music studies are strongly encouraged to join a Vocal Group to further their skills.

#### 3. CONTEMPORARY BANDS PROGRAM

The College offers a wide variety of contemporary instruments and music styles. These range from rock, metal, reggae, pop, funk and R&B through to jazz and fusion. There are many College bands and ensembles in the contemporary program including year level Rock Bands, Stage Band, Groove Orchestra and a variety of student-based bands and solo performers. (Available bands and ensembles may vary according to campus).

Students learning a contemporary instrument at the College are expected to make themselves available to participate the College's Performance Program. Voice students are expected to sing in an appropriate Vocal Group.
